Manex is a nonprofit consulting firm whose goal is to grow commerce. Success requires planning, not luck. Survivors focus on data and research and do not run on assumptions. They invest time and effort and take measures and conducts analysis with them. Thrivers devour data and research and spend and invest, and adopt a model of 'fail cheap, fail fast'. Thrivers automate measures and analyses and ask employees for input and allow them to invest. Some questions to ask

Does it take me more than 60 seconds to pull up customer information?

Does it take me or the staff 15 minutes or more to get started each morning?

Does everyone in our organization know our strategy?

Know where you stand – use information about competitors to set goals and measure success. Target the best in class, not the average. Transition from knowing to improving. Teach the concept. Prove the concept. Implement the concept.

An Excerpt from: A CENTURY OF SERVICE – The Story of Rotary International, by David C. Forward

Introduction

Even the world's mightiest rivers have humble beginnings. They start as tiny springs, bubbling to the surface, or as a single, melting snowdrop. As the rivulet trickles down, it brings new life to everything it touches. Soon, other tiny streams join its path and together they unite as a river, ever more confident and forceful.

One hundred years ago, the river called Rotary was born. A lonely lawyer named Paul P. Harris called together three business associates for an evening meeting. They shared similar backgrounds and missed the friendliness and trustworthiness of dealing with people they knew. Compared to the small communities of their boyhood, the frantic pace of life in America's second-largest city was depressing and lonesome. That night, they decided to form a club where they could meet and deal with one another in friendship and trust. It was the spring that started the river.

The United States had many clubs in 1905. There were trade and labor groups as well as associations of people who shared common ethnic backgrounds, religious beliefs, and political persuasions. But Paul Harris, Silvester Schiele, Gustavus Loehr, and Hiram Shorey wanted their new Rotary club to be unlike any other. Instead of having numerous lawyers or banker or accountants, they wanted only one man to represent each profession. They soon attracted other members, people from diverse backgrounds who found respite from the strains of big city business at the meetings where fellowship and jocularly took them back to their boyhood days.
